Message from the President

I started last year's column with this sentence: "2016 has been a challenging year, but as I look back on it, Unit 361 is in good shape." Well, it's the same for 2017. We had some hurdles to hurdle, and there are more in our future, but we're still doing well.

Site hurdles

The first hurdle was the discovery, late in 2016, that our usual Jeffco site was not available for our January 2017 sectional. Long story, and lots of work, but we found a substitute site at Arapahoe County Event Center. Our January attendance was down, probably in large part to this last-minute scramble, but those who played there were very happy with the facility. However, it's significantly more expensive than Jeffco, so when the contractual issues with Jeffco were worked out, we returned to our normal playing site.

We've had some other expenses related to the playing site: Jeffco has changed our status to "standard commercial," resulting in a rate increase, and the cancellation of another substitute site (related to Jeffco's planned but cancelled remodel) cost us a cancellation penalty.

Money hurdles

As is the case across the US, attendance at bridge tournaments is decreasing while costs are increasing. A variety of cost-saving measures have been implemented: most significantly, no more free lunches on Friday and Saturday. We just can't afford it. See p. 7 for a more detailed discussion of the lunch issue.

We also switched to digital-only TableTalk, and every-other-year printed directories. These changes saved approximately \$3000 in 2017. See p. 5 for a snapshot of our finances year to date.

The nominating committee is pleased to present the following candidates for the Unit board, for the two-year term beginning in 2017. The list is in alphabetical order.

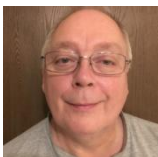
The election will be held at the annual membership meeting, 2:45 pm on Saturday, November 11, 2017, just before the second Saturday session.

In college at Princeton, she met future husband Dave Caprera and they played social bridge practically every night. Bridge was mostly forgotten for Anne during the years when the two children were growing up and she was a pathologist at Saint Joseph Hospital. The Bridge Legacy of Forest Clark

If you have played in Denver clubs or tournaments for any length of time, you have played against Forest Clark. Always courteous, always trying to sneak something by you – Forest loved the game and wanted it to thrive.



What you may not know is how Forest contributed to keeping the game alive. The early history of Denver bridge is not documented, so I'm relying on the memories of our long-time players, but here's what I've discovered. The Denver unit was organized and chartered by the ACBL in 1971. By 1974 or 1975, the unit was seriously in debt. One of the local players lent the unit \$10,000 to pay immediate expenses. After the immediate debt issue was addressed, it was proposed that the unit apply for corporation status, so that individual officers would not be personally liable for the unit's debts, or personally liable in any suits that might be brought. Forest prepared and filed the incorporation papers in 1976. Forest also played a major role in drawing up the unit's bylaws, and contributed to their occasional revision over the years.

In 1982, Forest was appointed legal counsel to the unit and he remained our legal counsel for the next 35 years, until his death. In this role, he attended most board meetings, provided legal opinions when appropriate, and made himself available for off-board consultation. I myself have discussed a number of issues or potential issues with him during my two years as president. Penny Coffman, who served as unit president for several years, recalls that Forest was instrumental in the successful resolution of several legal issues that arose during her tenure.

I will always remember Forest's balanced, well-intentioned approach to unit processes and operations. We did not always agree but I always knew that he wanted only the best for us all.

Remembering Forest

To help us remember Forest, and to do a little good in his honor, the bridge board voted unanimously to:

- Rename the Mt. Massive charity pairs game at the Denver regional to the **Forest Clark Charity Pairs**.
- Declare the Friday night game at the upcoming November sectional the **Forest Clark Memorial** game, and donate the proceeds to hurricane relief.

(Thanks to Jennifer O'Neill and Bill Allegar for the suggestions.)

A little more about that Friday game. It will be run as an individual – yes, that's right, show up without a partner and play with 9-12 different partners, 2-3 boards each. This will test a whole different set of bridge skills☺

Everybody will be required to play SAYC (Standard American Yellow Card). We'll have a supply of those at the game so you don't have to bring one with you, or even study it ahead of time. And you can look at your card during the bidding and play.

Profit from the game (card fees minus sanction fees, director fees, and caddy fees) will be donated to hurricane relief, to a charity of the Clark family's choice.

Penny Coffman Appointed Unit 361 Legal Counsel

Penny Coffman has been appointed to serve as legal counsel for Unit 361.

Penny is very qualified for this position. She has wide experience of the law, having been an attorney, a prosecutor, and a judge in a number of different jurisdictions. She has also served on the unit board, as caddy master and as president, so she understands the needs and procedures and processes of the board and the unit. She has reviewed the unit bylaws in detail, more than once. She was caddy master for the 2005 NABC here in Denver, and she has served on several nominating committees and has been unit recorder several years. She has also played in our unit and at our tournaments for 15+ years.

Penny will serve as legal counsel and recorder simultaneously, and will recuse herself if any conflict-of-interest situations arise.

I am sorry that we no longer have Forest's expert and balanced input, but I am also confident that Penny will serve the board and unit well.

Is There a Free Lunch?

Starting several years ago (12? 15?), the Denver unit board took advantage of the increased space and increased profit that came with holding the sectional tournaments at Jeffco, and started offering a free lunch on Fridays and Saturdays – returning the profits to the players. Prior to that, Friday and Saturday lunches were “on your own,” as is the case with most or all sectional tournaments across the US.

At that time, Jeffco policy allowed the unit to bring its own food in, using its own people as volunteers. A lot of the food and all the work were contributed by unit members.

At some point, Jeffco policy changed. We could not bring our own food in, and we had to use an approved caterer. Lunch costs went up significantly. Abuse of the Friday free lunches has been observed: People who played only the morning session stayed for lunch, and people who were playing only the afternoon session came early to eat lunch. The free lunch was intended as a convenience for people who were playing both sessions. We have also had trouble on both days with people eating more than their share, so that people toward the end of the line didn't get any of the main course.

Data from 2015 and 2016 shows that the Friday and Saturday lunches cost ~\$1300-\$3000 each, contributing to tournament losses of anywhere from \$1500 to \$4800.

We've tried to address the lunch problem by converting Friday and Saturday to “meal tickets for purchase.” This has had its own problems: The caterer runs out of food; people aren't satisfied with the meal. When you look at it from the caterer's point of view: He has to figure out how many people to serve, buy the food, prepare it, do all the setup and cleanup, pay his staff, and make a profit. Having a decent hot meal served on site by a caterer is expensive. Holding the costs down means limiting the quality and amount of the food.

Looked at from the larger perspective of the annual budget: Historically, if the sectionals broke even, the regional brought in enough income to meet the unit's expenses. Regional profits have declined in the last two years, and my guess is that they will continue to decline. This means that the sectionals will need to shoulder more of the load (and, of course, the unit must continue to cut expenses wherever possible).

Bottom line – the lunches were not free. We have been eating our capital. We will continue to try to provide a reasonable, reasonably priced on-site lunch, but unfortunately, there is no affordable solution that will please everybody.

District 17 Update

Denver Unit 361 is part of District 17, which includes all of Arizona, Colorado, and New Mexico plus Las Vegas, Nevada; El Paso, Texas; Moab, Utah; and Southern Wyoming (Cheyenne and Laramie). The Denver unit currently has two members on the District 17 Board of Directors.

District 17 has been experiencing reduced attendance at pretty much all of its regional tournaments. Unfortunately, this decline in participation is occurring at all levels of the ACBL, including National, regional, and sectional tournaments and at club games in all parts of the country. This decrease in table counts is putting financial pressure on both District 17 and Denver Unit 361. The district board is taking two steps to address this financial pressure.

Reducing the number of board members

At the June 2017 meeting in Las Vegas, the District board voted to reduce the size of the district board from 14 elected directors plus the National Board Representative to 10 elected members plus the National Board Representative. This reduction, which will be effective on January 1, 2019, is expected to reduce district expenses by over \$5,000 per year. (Board members receive travel expenses to attend three board meetings yearly.) At the same time, terms will change from two years to three years.

As a result of this change, the Denver Unit (and the Phoenix Unit) will have only one board member (versus 2 board members currently). To transition to this new structure, the board member elections held in 2017 for calendar year 2018 will be for either one-, two-, or three-year terms, depending on their position in the election cycle. Because the Denver #2 board

seat (currently held by Jerry Ranney) will be eliminated at the end of 2018, the 2017 election is for a one-year term. Starting with the 2018 elections for 2019, all elections of board members will be for three-year terms, including the Denver board position currently held by Jennifer O'Neill.

Leaving the Western Conference

The other major cost-cutting effort is the D17 board decision to resign from the Western Conference (WC). District 17 has been a long-time member of the Western Conference and was reluctant to drop its membership at this time. WC membership provides the monthly Forum/Scorecard, and the cost to District 17 is around \$80,000 per year. A Blue Ribbon committee of WC members from the three districts in the WC was appointed to look into the

future direction of the WC, and the committee recommended that D17 become a test case for switching to a digital version of the newsletter, with an option for any district member to continue receiving a printed version of the publication. The WC denied this request, so the district felt it had no choice but to drop its WC membership.

Although there will be start-up costs in switching to a new communication vehicle for D17 members, we ultimately expect to decrease cost by switching to a more digital-based publication. We expect the new newsletter will be semi-monthly and will be some combination of digital and printed versions. The new communication vehicle is expected to go into effect around April of 2018. We plan to have updates on the transition process in upcoming District 17 ScoreCards, so stay tuned for those updates.

New Player Development

The Board of Directors of Unit 361 is dedicated to growing the bridge world in Denver. Attendance at the club level and in tournament play is steadily decreasing to the great dismay of all of us. The board is optimistic that this decrease can be reduced to a trickle through the development and encouragement of new players.

I met with a few newer players recently at the seminar presented by Jerry Helms in Vail. The consensus was that a singular barrier into the arena of competition is a lack of confidence. Sitting at a table in a club or tournament for the first time causes anxiety and fear of mistakes. It takes some experience and support to realize that everyone at every level of play makes mistakes and learns from them. A program for new players must include academics, experience, support, and opportunities.

In 2017, the unit's newer-player program includes a coaching program, a Help Desk at sectional tournaments, and two Intermediate/Novice sectional tournaments.

Coaching is aimed primarily at partnerships but may include individuals. Coaches are excellent bridge players who volunteer their time. The coach and player(s) establish individual goals, meeting at their own convenience. The program is an adaptation of the

popular mentor program. If you are interested in participating in 2018, keep your eyes open for flyers and sign-up information.

Help Desk is held between sessions at sectional tournaments. It is staffed by local bridge experts. Players can bring questions that arose in the previous session, difficult hands, bidding questions, etc. to receive immediate advice and guidance. (Editor's note: Due to very low traffic, the Help Desk is being discontinued. It could be brought back if enough people express interest.)

Intermediate/Novice tournaments are designed to provide a safe, competitive sectional tournament for people with 299 or fewer masterpoints. Information on these tournaments is available on the ACBL website and the unit website.

In addition:

- Several local clubs run "limited" or "mentor/mentee" games, which have upper masterpoint limits for players.
- Lessons are offered by local teachers. A partial list of teachers, with contact information, is available on the unit website. Also, feel free to contact the clubs to ask for current lesson schedules.

The board wants to support newer-player development projects. If you have an idea for newer-player development and outreach, please contact a board member.
